The Company shall not be liable for any incidental or consequential damages, damages caused by breach, cancellation or suspension of this agreement, whether or not the possible reasons for such damages is known to the Company.

Any Member/Customer/Executive involving in any activities against the aims/objectives, Rules & Regulations of the Company such person would be removed without notice and appropriate action would be initiated against him as per the Criminal and Civil Law.

Any Member/Customer/Executive shall not be construed as the permanent employee of the Company.
